

Bylaw Proposals for AGM Nov. 17th 2009

1 To be added:

ARTICLE XV - UNIFORMS AND EQUIPMENT

To maintain consistency in the club, any change of uniform or Club logo is subject to the following rules.

- 1 Only one vote per year is allowed and the vote must precede by 30 day notice to all voting members of the club.
- 2 The vote must receive a 75% majority of eligible members with a positive vote requesting a change.
- 3 Change of printing is exempt from this rule when adding or removing club sponsors
- 4 The use of t-shirts for spring soccer is not subject to this rule

2 To Be added Under: ARTICLE X - PLAYER REGISTRATION

Refund policy

DDSC will, at Board's discretion, refund of up to 50% of paid registration fee, if your child is deemed unable to play due to a medical condition.

Or

DDSC will refund 100% of paid registration fee if your child is NOT placed on a team due to lack of space.

Please submit, in writing, your request to be refunded. Include a copy of a signed Doctor's order if applicable.

The DDSC Board will review your request at the next monthly board meeting and will notify you of their decision within 7 days after the meeting.

3 To Be added Under: ARTICLE X - PLAYER REGISTRATION

A player is not eligible to participate in practices or games until all fees are paid in full before the first scheduled game of the season, unless an alternate payment plan has been made with the club treasurer. Failure to adhere to the payment plan will be grounds for immediate suspension from all games and practices. Registration for subsequent seasons will not be accepted until all previous fees have been paid in full.

4 To Be added Under: ARTICLE X - PLAYER REGISTRATION

Volunteer Requirement

Along with registering a player the parent or guardian agrees to the following volunteer requirement:

5 hours per year per player with a maximum 10 hours per family.

Or opt out for \$8 per hour for hours not fulfilled.

5 In Section: ARTICLE XV - UNIFORMS AND EQUIPMENT

Paragraphs two and three to be changed from:

The DDSC shall be responsible for the purchase and disposition of all uniforms and equipment,

except for shin guards, shorts, shoes, and balls for each playing season. Shin guards are mandatory for all players (practice and games).

The fall season uniform shall consist of: one shirt and one pair of socks, all in the DDSC colors. The DDSC registration fee will include the purchase of one shirt and one pair of socks which will become the property of the player; however, if the DDSC is in the uniform business the jersey becomes property of the club and **WILL BE RETURNED** at the end of the current season of issue.

To:

The DDSC shall be responsible for the purchase and disposition of all uniforms and equipment, except for shin guards, shorts, socks, shoes, and balls for each playing season. Shin guards are mandatory for all players (practice and games).

The fall season uniform shall consist of: one shirt, black soccer shorts, and one pair of socks, all in the DDSC colors. The DDSC registration fee does not include any part of the uniform. The player is responsible for the additional costs of the uniform which is the property of the player; however, **IF** the DDSC is in the uniform business and has issued a player a uniform without additional charge, the uniform remains the property of the club and **MUST BE RETURNED** at the end of the current season of issue.

6 Under REFEREE COORDINATORS Change from:

They shall submit to the board for its approval a scale of compensation and the number of referees per game(if any) along with an estimated current season budget.

To: They shall submit to the board for its approval a change in the current scale of compensation and the number of referees per game(if any) along with an estimated current season budget.

7 Add new section after Article XVIII, before Article XX

ARTICLE **: Referee's Pay Scale

Per Game pay schedule Referees :

No refs for Micro games

\$15 per game for U8/U9 games, one center ref, volunteer parents for sideline refs

\$20 per game for U10/U11 games, one center ref, volunteer parents for sideline refs

\$25 per game for U12/U14 games, one center ref, volunteer parents for sideline refs

This pay scale can be amended through the provisional rule vote process

8 ARTICLE XIX - SCHOLARSHIPS

Change from:

Each year the DDSC will award two (2) five hundred dollars (\$500.00) scholarships to the most qualified male and female applicants of the graduation class as defined by the DDSC Board.

TO:

If funds have been received from high school soccer clinics, and/or another dedicated source, the DDSC will award up to two (2) five hundred dollars (\$500.00) scholarships to the most qualified male and female

applicants of the graduation class as defined by the DDSC Board.

9 Add under **ARTICLE VI - ORGANIZATION**

Add **Events Coordinator** one each to be elected in both odd and even years

Add **Uniform & Merchandise Manager** to be elected in even number years

10 Change: **Under ARTICLE VII - MEETINGS**

From:

General and or special meetings shall be held at 7pm on the first Monday of every month except November at Pizza Baron, 2604 SE 122nd Ave, unless specified by the President or the Board with a minimum one week notice of change to all members via email or phone. If the meeting date falls on a federal holiday, then the meeting will be postponed until the following Monday. Meetings in September, October, November and December may be on a different day due to Monday Night Football at Pizza Baron

10 To be changed:

Reduce number of registrars to One from Two. The single registrar will be elected in the even number years. Wording in the Bylaws will be changed in the appropriate places to reflect this decision if this proposal passes

11 To be changed:

Reduce number of Referee Coordinators to One from Two. The single registrar will be elected in the even number years. Wording in the Bylaws will be changed in the appropriate places to reflect this decision if this proposal passes

12 To be added: Under **“ARTICLE VI - ORGANIZATION”** after **“Fiscal Year”**

Online Security

Passwords for the any part of the web site and passwords for administration of the Affinity Online Registration system are to be kept confidential to only members of the DDSC board. Any board member giving a club password to anyone not explicitly authorized by the DDSC board will be considered immediately suspended from their position(s) on the DDSC board with the possible dismissal from the DDSC Board. The DDSC Board will review the breach of security and vote to determine the status of the violating board member at the next scheduled board meeting. The decision can be postponed one meeting to gather additional information regarding the violation.
